In what cases and in what amount will socially vulnerable families and persons with disabilities be able to receive compensation?

1. The rating score of our family is between 65 000 and 100 001, are we eligible for any assistance?

If the rating score of your family is between 65 000 and 100 001 in the unified database on socially vulnerable families, *each member of your family shall receive GEL 35* for six months from May 1, 2020. Exceptions are families with one or two members. In particular, onember families will be compensated in the amount of GEL 70 and two-member families - in the amount of GEL 90.

2. We are in the database on socially vulnerable families, our rating score is less than 100 001 and we have three children under the age of 16, are we eligible for any assistance?

The families with rating score of less than 100 001 in the database on socially vulnerable families, which have 3 or more children under the age of 16 years, *shall monthly receive GEL* 100 for 6 months from May 2020.

3. I am a person with disability, do I have the right to receive compensation?

If you are a person with severe disability or a child with disability, you will be given GEL 100 on a monthly basis for 6 months from May 6, 2020.

4. When and to whom should I apply for getting compensation for socially vulnerable families/persons with disabilities?

If you already are in the unified database on socially vulnerable families and/or already have the disability status, you are not required to file an application anywhere. The Social Service Agency shall identify recipients of compensation and transfer compensation along with social package/state compensation and/or substance assistance.

5. If 66 000 points were granted to my family after May 1, 2020, (May 15) will I receive GEL 100 per month?

In this case, the above compensation will be paid from the month following the one when you were granted the points (in this case - from June), during the remaining months of this compensation programme (till November).

6. I was granted the severe disability status after May 1, 2020 (July 1), will I get GEL 100 per month?

In case of being granted the severe disability status or the status of child with disabilities after May 1, as well as in case of applying for compensation under the mentioned status(s), compensation will be paid from **the first day of the month following** the one when the person/legal representative submitted the relevant application and the copy of medical-social examination act to the Service Agency in writing or electronically, and you will receive it during the remaining months of this compensation programme.

7. Our family consists of 5 members, 3 of whom are children under the age of 16, our rating score is 67 000 and one of the full-age members of our family has severe disability status. Do I have the right to receive all three compensations?

It is not prohibited to receive compensations on all the three grounds (intended for socially vulnerable families and persons with disabilities), if there are relevant preconditions. In this case, you have the right to receive GEL 100 for 6 months from May 2020 (on the ground of having 3 juvenile children and the rating score lower than 100 000) + monthly compensation for each family member in the amount of GEL 35 for 6 months from May 1 (GEL 175 in total) + persons with severe disabilities have the right to simultaneously receive GEL 100 per month for a 6-month period from May 2020.

8. Our family is in the unified database on socially vulnerable families and we receive subsistence assistance. If we receive compensation, will the amount of money received in compensation affect the family's rating score?

It will not, because when compensation is appointed on the above grounds, the amount of money received in compensation by the family will not be taken into account when determining the rating score of socially vulnerable families.

9. We have been compensated from May 1, because our family's rating score was less than 100 000 and we had 3 minor children (under the age of 16 years). One child turns 17 in July. Will we stop receiving compensation for this reason?

No, because the compensation intended for large, socially vulnerable families is valid for a full period, and changes in the number of children aged 0-16 after the appointment of compensation will not result in termination/suspension of compensation.
